# PARISH COUNCILLOR VACANCY - Lower Ward

Whittingham Parish Council covers the areas between Langley Lane / Goosnargh Village (Lower Ward) and Cumeragh Lane to Halfpenny Lane / Inglewhite Road (Higher Ward).

A Councillor vacancy has occurred in **Lower Ward** and anyone interested in the role, is invited to apply to be co-opted on to the Council. Meetings are usually held once a month in Goosnargh Village Hall on a Thursday evening and last for approx. 2 hours depending on the items included on the agenda.

The Parish Council is a consultee on planning and highway matters and works closely with the police to resolve issues in the Parish.

This is an exciting time to join the Parish Council as we seek to create a **woodland walk** along Whittingham Lane, create a **gym area** on Goosnargh Village Green and improve and enhance the Parish through the appointment of a **Parish Lengthsman** - more details are included inside this Newsletter.

## **ANNUAL PARISH MEETING**

The Annual Parish meeting will be held on **Thursday 22nd May at 6.30pm at Trinity Methodist Church.** This is a temporary change of venue as meetings usually take place in Goosnargh Village Hall.

The purpose of the Annual Parish meeting is to recap on the Council's activities, receive reports from your elected County and City Councillors and hear from local community groups who have benefitted from the Council's support.

Following the Annual Parish Meeting, the **Annual Council Meeting** will be held. The Chairman will be elected and the Council will confirm the administrative policies and procedures for the forthcoming year.

#### **IMPROVING OUR PARISH**

#### **Parish Lengthsman**

The Parish Council is delighted to announce the appointment of **Mark Cornforth** as our Parish Lengthsman. The term dates back to the 1700s and originally referred to someone who kept a length of road, neat, tidy and passable with particular emphasis on boundary marking. The more modern meaning is someone to keep grass and weeds down in the verges, keep



drainage ditches clear, repair fences, plant and tend wild flowers and carry out general maintenance and repairs around the area. Mark will also be checking the **Parish Walks** to ensure they are kept free of vegetation. #### **Goosnargh & Whittingham in Bloom**

Mark will also help to support the work of Goosnargh & Whittingham in Bloom, a community group with aspirations to keep the parish tidy and enter areas into the Best Kept Village competition. #### **Grounds maintenance**

We are also pleased to announce that the grounds maintenance contract has been awarded to **Millars**. They will be monitoring the play area and cutting the grass at **The Square** and will also tidy the garden area around the Memorial at **Beacon Drive**.



#### **NO COLD CALLING ZONES**

Residents have reported an increase in traders 'cold calling' in the parish so the Parish Council has worked with Lancashire County Council to introduce some **No Cold Calling Zones**. Regrettably these only cover certain areas but signs will be erected in May / June.

Traders will not be committing an offence if they call to properties in the zone, put hopefully they will be deterred and residents will have the confidence to say **'no'** due to the no cold calling zone.

#### **SCAMS & PHISHING EMAILS**

Always be on the alert for scam texts or emails claiming to be from a delivery company seeking to reschedule or request additional delivery fees. Scam texts can be reported to the National Cyber Security Centre by forwarding it to **7726.** Also be suspicious of unusual or out of character



email requests from people you know. Double check the email address the email has been sent from or speak to the person concerned. You can report suspect emails and calls to Action Fraud on **0300 123 2040** or via www.actionfraud.police.uk. Scam emails can also be reported via report@phishing.gov.uk.

#### POLICE

# **PLANNING APPLICATIONS**

**Housing applications** are once again taking up a lot of the Parish Council's time. In December, the City Council declared that it did not have a 5 year supply of housing land which meant that the **tilted balance** in favour of development was applied. More information is on our website www.whittinghamparishcouncil.org.uk/news.php

Although the City Council is confident that the supply will be restored in May / June, a planning application was submitted for 95 homes at **Swainson House Farm.** The Parish Council objected to the application and Councillors will speak in person against the application when it is presented to the Planning Committee.

Gladman's have also issued a consultation proposing 145 dwellings off **Churchgate**. The consultation closes at the end of April but information is available on Gladman's website. www.your-views.co.uk/landoffchurchgate/



Although a planning application has not been submitted yet, the Parish Council will continue to monitor the situation and object to any proposals.

The City Council is in the process of updating its **Local Plan** which details **Allocated Sites** and the **Planning Policies** to be applied when determining applications. Once adopted the Local Plan should strengthen many of the existing Policies designed to prevent development in the open countryside.

The Local Plan will be presented to a Planning Inspector who will determine if the Policies are sound and whether more land should be allocated for development. The Parish Council was pleased to note that many of the sites put forward for development around Whittingham were not taken forward however the Parish Council remains fully and actively engaged in the decision-making process. in the hope it can influence any proposed changes.

A meeting has also taken place with Barratts to discuss their development of 477 homes at the former **Whittingham hospital site**. This application has been proposed for some considerable time and the Parish Council wants to make sure that the history of the site is reflected in the development and the open space is retained and managed properly. Lancashire County Council have also submitted plans for a **new primary school** on Henry Littler Way and the Parish Council will continue to work with them to resolve parking and highway concerns.

#### **GOOSNARGH VILLAGE GREEN**

**Ninja gym equipment** - The Parish Council is keen to ensure that the Village Green can be used for recreational purposes by everyone. In partnership with Preston City Council, we are working on plans to add a **Ninja style obstacle course** for children between the ages of 11 and 16. The proposed equipment will include a climbing slope, monkey bars and a warrior ramp. **Details of the proposal can be viewed on our website.** The equipment is likely to be located halfway between the trees and the litter bin at the tennis court end of the Village Green. Discussions are still at a very early stage, so please email the Clerk with your views on the proposal.



#### **VE DAY**

The 8 May 2025, will mark the **80th anniversary of VE Day**, when the nation will unite to remember the end of the Second World War.

The Parish Council has arranged for an inscription to be added to the Memorial on Beacon Drive and a Proclamation may be read to mark the event. Exact details will be confirmed on our website. St Mary's Church bells will also ring intermittently from 18.30 onwards.

Events will take place around the country to pay tribute to those involved in the conflict as well as reminding us to pray



#### **COMMUNITY INFRASTRUCTURE LEVY**

New development leads to the payment of a Community Infrastructure Levy which is passed to the Parish Council to improve and enhance facilities and infrastructure in the local area.

The Parish Council maintains a CIL Business Plan which identifies projects to be funded from CIL. To date CIL has been used to

- Upgrade the footpath between Goosnargh Village Hall and Goosnargh play area and clear and open 2 circular walks on public rights of way in the Parish
- Provide **3 Speed Indicator Devices** which capture data to illustrate that speeding remains an issue to be resolved
- Improve lighting at Goosnargh Tennis Club and Longridge Football Club
- Provide a new roof at Goosnargh Village hall and a new cooker for Trinity Methodist Church
- Add and improve Parish assets including new signs on the Parish boundaries and Goosnargh Village Green, replacing the paving stones at Beacon Drive Memorial, painting and maintaining the Halfpenny Lane phone Kiosk and providing new planters and benches across the Parish
- Contribute to the repair of the **village clock** housed in St Mary's Church.

As stated on page 3 of the Newsletter, we propose to create an **obstacle course** on Goosnargh Village Green and we aim to financially assist the City Council in replacing the **multi-use play tower** in the play area. Discussions are also taking place to assist the Scouts in finding a site for a new **Scout Hut**.

Due to the size and cost of the project, plans to bring **St John's Church** back into community use have put on hold, however, we are progressing an aspiration to create a **Woodland Walk** along Whittingham Lane, between Cumeragh Village and Henry Littler Way.

Proposals to extend **Trinity Methodist Church** and improve the toilets at **Whitechapel Village Hall** are pending whilst the organisations consider if supplementary grants can be applied for.

The Parish Council is always keen to hear suggestions from residents and if we can't provide the improvements ourselves, we will continue to do our best to negotiate with Homes England, Highways or the City Council to improve the Parish for the benefit of all.

#### FINANCES

In addition to the CIL payments, the Parish Council is financed through your payments towards the **Council Tax**. The end of year accounts for 2024/25 will be presented to the May Annual Parish meeting and the budget for 2025/26 is printed below.
