PLANNING UPDATE

Under the Adopted Core Strategy, Preston is required to allocate enough land to build **507 new homes** every year for 5 years - but developers have either not started building or are building at a slow rate which resulted in the City Council conceding that it did not have a 5 year housing supply. When this happens, the Development Plan Policies - which are used to determine local applications - are given very little weight and there is a presumption **in favour of development**

In our opinion developers took advantage of this and submitted a number of housing applications in and around Whittingham Parish. Instead of refusing the applications because they do not comply with the Development Plan Policies, **the applications were recommended for approval by the Planning Committee**.

Following intervention by Ben Wallace MP, the Secretary of State was asked to investigate the impact of so much development in one area - and the applications were put 'on hold' and the decision notices were not issued.

CHANGE TO THE 5 YEAR SUPPLY

Whilst the applications were 'on hold', the Government issued a Standardised Formula for calculating housing need. If the new formula is used, Preston's Housing Need figure could drop significantly to **241 homes** as going forward, the City Council would not need to take into account the historic shortfall of homes not built.

During a recent appeal in South Ribble, a Planning Inspector determined that the 3 authorities could use the Standardised Formula - which led to the City Council REFUSING the 'on hold' applications in accordance with the Development Plan Policies as it now has a 5 year supply.

Wainhomes have lodged a High Court Challenge against the South Ribble appeal decision. There are FIVE grounds on which the developer is contesting the decision and it is understood that the Secretary of State has conceded on ONE of those grounds.

Currently, Preston City Council and South Ribble Council are standing by the Planning Inspectors decision - until or unless it is set aside by the High Court. **IF** the legal challenge is successful and **IF** the decision has a bearing on the 5 year supply, it is likely that the refused applications will either go to appeal, or will be resubmitted.
