FORMER RIDINGS SITE

Following complaints about the disused site at Whittingham Road, the Parish Council arranged to have the site secured and fenced off prior to demolition to make way for a housing development and Aldi supermarket. The Parish Council raised drainage concerns before the applications were approved and are currently seeking flooding reassurances regarding the approved scheme.

WHITTINGHAM ROAD / INGLEWHITE ROAD / HALFPENNY LANE

Lancashire County Council are proposing a temporary road closure with parking restrictions on Whittingham Road, Half Penny Lane and Inglewhite Road from the 26th June 2017 - 18th December 2017 to enable utility works and highway alteration works to take place for the new development. Details are on the Parish Council website. The Parish Council is concerned about the disruption and is working with the County Council to try to get this reduced. Residents are requested to register any concerns with LCC by calling 0300 123 6701 quoting reference HRiT/7862/EF.

2016/17 FINANCIAL REPORT

After the deduction of un-cleared cheques, the financial year began with a carried forward balance of £109,215.40 of which £19,906.76 was held in the bank account and £89,308.64 Community Infrastructure Levy was invested in a short term deposit account. Expenditure plans for CIL are detailed on a separate CIL report.

Itemised Income and Expenditure for the year are recorded below.

The closing balance for 2016/17 is £113,160.84 of which CIL Investment remains at £89,308.64 and £23,852.20 is in the bank account.

The carried forward figure includes £1,751.95 CIL income not transferred to the investment fund and £5,309.76 for Cumeragh Play Area Inspections and maintenance where invoices were expected but not received before the financial year end.*
