HOUSING DEVELOPMENT UPDATE

Residents will be aware that the Parish Council has repeatedly **opposed new housing development** in Whittingham as the Parish Council does not consider there are sufficient amenities, services and employment opportunities to serve existing residents, let alone new residents! In addition the Parish Council has **grave concerns** that the narrow, rural roads will not accommodate the additional traffic.

Unfortunately, officers and the majority of the Members of Preston City Council Planning Committee, feel they have **no grounds to refuse housing applications** because Preston (as a whole) has a housing shortage and Central Government is asking Councils to make up the shortfall.

The Parish Council has repeatedly questioned if the City Council can **demonstrate the local level of need - so that homes can be built according to where the demand is -** and, in the absence of a satisfactory reply, the Parish Council made a carefully considered decision to submit a **Motion of No Confidence** in the City Council Planning Department. The City Council has strongly objected to the Parish Council's action and a meeting has been arranged to see if an 'understanding' can be reached.

In addition to the above, the Parish Council and local residents asked Ben Wallace MP to call the 'approved' applications before the Secretary of State so he can assess if the situation in Whittingham is **in accordance with Government Policy.** Until the Secretary of State rules on the policy position, the City Council's decision to approve the applications is currently **'on hold'.**

HOLME FELL

The only exception to the above is Holme Fell which was approved **prior to** the City Council establishing it did not have a 5 year housing supply. The application was approved with a **Community Charter** and we have arranged a meeting with Contour Homes to discuss how the community can be assured that the 'commitments' in the Charter will be delivered.

We are expecting building work to commence shortly and we would like to advise residents that **any problems with construction work** such as mud or construction vehicles blocking the road should be reported to the City Council.

WHITTINGHAM HOSPITAL SITE

Residents will be aware that Taylor Wimpey are building **150 homes** at the former **Whittingham Hospital site** off Henry Littler Way and Homes England have submitted an outline application **06/2019/0365** for a further **750 homes** taking the total number of dwellings to 900.

The application seeks **approval for access** for the development of up to 750 dwellings; the redevelopment of the Sports and Social Club and associated outdoor facilities; reservation of 1.5 hectares of land for a primary school, 3 dwellings at the former waste water treatment works, landscaping, public open space and other on-site infrastructure.

Obviously this is a complex application - especially as a Legal Agreement exists 'promising' various amenity and service improvements as part of the original application. With this in mind, the Parish Council has requested a meeting with the City Council to establish what aspects of the application can be considered at this outline stage and if the Legal Agreements will still apply. As soon as we have a steer on this, we will advise residents so that relevant comments can be made in response to the application.

CIL MONIES

Most housing developments have to pay a Community Infrastructure Levy and 15% of the money collected is passed to the Parish Council to be spent on infrastructure improvements in the Parish. Full details of the income and expenditure for 2018/19 can be found on the Parish Council website www.whittinghamparishcouncil.org.uk.

During 2018/19 the Parish Council added a new surround to the Memorial on Beacon Drive and increased the awareness of the Parish through the addition of new boundary signs.

During 2019/20 we provided a bench and litter bin on Halfpenny Lane and our thanks are expressed to the kind resident who anonymously added some bedding plants to the location.

The Parish Council is also aiming to improve the Public Rights of Way with a view to producing leaflets to promote walks around the village and



is considering the installation of Solar Powered Speed Devices.
