FINANCIAL REPORT FOR 1st APRIL 2019 TO 31st MARCH 2020

The year started with a carried forward balance of £142,932 of which CIL monies totalled £124,026 and Council reserves totalled £18,906.

Itemised Income and Expenditure for **2019/20** is recorded below leaving a year-end balance of **£172,873**.

During **2019/20** the Council received **£24,347** in CIL monies and spent **£17,482** on 3 solar powered speed signs, an inspection in to the Public Rights Of Way, a new bench and 2 waste bins leaving the **2019/20** CIL balance as **£6,865** - which when added to the 2018/19 CIL carried forward total, leaves a total CIL balance of **£130,891**

The 2019/20 year-end balance of £172,873, less the CIL balance of £130,891 leaves the Council with reserves of £41,982, however £20,530 relates to the 2020/21 Precept leaving an actual reserve balance of £21,452.

PLANNING SITUATION UPDATE

Under the 2012 Core Strategy, Preston was required to allocate enough land to build **507 new homes** every year for 5 years but due to developers not starting projects or building homes at a slower rate than expected, the City Council conceded that it did not have a 5yr housing supply. This meant that the Development Plan Policies - used to determine local planning applications - were given very little weight and there was a **presumption in favour of development being approved.**

In the Parish Council's opinion, developers took advantage of the above and submitted a number of housing applications in and around the Whittingham area which were all recommended for approval by the Planning Committee. As this would substantially change the rural nature of Whittingham, Ben Wallace MP, asked the Secretary of State to investigate the impact of so much housing in one area, and the applications were put 'on hold' which meant the decision notices could not be issued.

CHANGE TO THE 5 YEAR SUPPLY

Whilst the applications were 'on hold', the Government issued a Standardised Formula for calculating housing need which meant Council's would not be required to take into account the historic shortfall of homes not built. Using the Government's Formula, Preston's housing need would be reduced to **241 homes pa**.

Following a period of uncertainty regarding whether the Government's lower figure could be applied, when considering an appeal at South Ribble, a Planning Inspector determined that Preston, Chorley and South Ribble could use the lower figure - which meant the on hold applications could be **refused** in accordance with the Development Plan Policies.

That still remains the case now, however Wainhomes have lodged a High Court Challenge against the decision. If this is successful, developers may also appeal against the refused Whittingham applications. Consequently we are waiting for the decision with interest and will update residents via our website and the GAWAOD Facebook page.

In a final twist, the City Council has entered in to a Memorandum of Understanding with Chorley and South Ribble to allow Preston to deliver **410 homes** pa. This is much closer to the **507** homes specified in the Core Strategy and it is hoped it will allow Preston to continue to grow, whilst maintaining a 5 year housing supply.

COMMUNITY INFRASTRUCTURE LEVY

Community Infrastructure Levy - often abbreviated to CIL - is a planning fee that applicants pay to Preston City Council for most new dwellings and developments which create additional floor space of 100 square metres or more. The City Council is required to pass a proportion of the planning fee to the Parish Council on the understanding the fee will be used to improve local services or infrastructure as a direct result of the new development or increased population.

- Since the funding started in 2015, the Parish Council has improved communication with residents by setting up the website and issuing quarterly newsletters,
- Created a new footpath between Goosnargh Play area and the Village Hall
- Provided CCTV and a defibrillator to the Village Hall
- Added a War Memorial on Beacon Drive
- Provided 'Welcome to Whittingham' boundary signs
- Added a new bench and bin to Halfpenny Lane
- Erected 3 solar powered speed indicator devices

We have also commenced an inspection of the public rights of way with a view to publishing some leaflets detailing walks around Whittingham. The next stage of this project is to engage a contractor to repair and replace some of the stiles and bridges to ensure the walks are safe for all.

Other suggested ideas include more CCTV and the provision of cycle stands.

As can be seen on the 2019/20 Financial Report on page 7, the Parish Council currently has approx £115,000 in CIL monies and we are eager for residents to provide ideas on how this can be spent. Ideas **must** relate to an increase in traffic or the additional demand on services caused by an increase in residents and new housing developments.
