Homes England have been working closely with the Sports & Social Club and Preston City Council to prepare a planning application for the community facilities, and we'd like your comments on the proposals.

Who are Homes England?


Homes England are the Government's housing agency and previously controlled the majority of the Former Whittingham Hospital site. Housebuilders including Elan Homes and Barratt are constructing the housing element of the development and Homes England retain responsibility to redevelop the Sports and Social Club.

Across England, Homes England work closely with local Councils, stakeholders and local communities to deliver homes and supporting services where they are most needed. We have a long term commitment to quality placemaking, investment in infrastructure and a track record of delivery that we are looking to continue.

What's proposed?

The proposed scheme consists of the redevelopment of the community and sports facilities at Whittingham and Goosnargh Sports & Social Club. The Section 106 agreement for the outline planning permission for the wider site sets out the specific requirements of this development:

- A new purpose-built sports & social club building;
- B A senior football pitch (11 a side);
- C A multi-use games area/tennis court;
- D Events/caravan/camping area;
- E Retention of existing bowling green; and
- **F** Associated car parking and landscaping.

Privacy Notice

About this notice

This privacy notice explains how Homes England collect, use and protect your personal data; and also the rights you have with regards to that data.

This notice applies to the processing of your personal data through Homes England's public consultation for the redevelopment of the site known as Whittingham and Goosnargh Sports and Social Club only. Who we are

Homes England is the trading name adopted by the Homes and Communities Agency, our legal entity.

We are the data controller of the personal data processed. This means that we are responsible for deciding how we collect, use, and store your personal data.

This consultation is provided by Tibbalds Campbell Reith who are contracted by Homes England as a Data Processor for the purpose of delivering the redevelopment scheme. Tibbalds Campbell Reith has sub-contracted this processing to Hive Land and Planning Ltd who are also a Data Processor.

Information we collect

Homes England collects personal data about you through this public consultation. We collect personal data from you when you submit comments about the proposed scheme. The types of personal data we collect, store and use are:

- Contact email address
- Personal opinions/comments (which may indirectly identify you)
- Contact name
- Postal address if comment provided by post

The primary purpose of this data collection is to collate comments from members of the public to inform the proposed redevelopment of Whittingham and Goosnargh Sports and Social Club.

How we process your information

We use the personal data stated above for the following purposes:

 Your information is sent to our data processor and their sub-processors, who are conducting this public consultation on behalf of Homes England. The data will be used to inform the proposed redevelopment of Whittingham & Goosnargh Sports & Social Club.

What lawful basis do we have to process your personal data?

We will only use your personal data when the law allows us to. This is called the lawful basis. Regarding the above purposes, we rely on the following lawful basis:

Public Task – Processing your data is necessary for the performance of a task carried out in the public interest or in the exercise of official authority vested in us, for example, for one of our statutory functions.

Who is the information shared with?

We use service providers to host this public consultation. When we use these service providers, it is necessary for us to share your personal data with them.

The main service providers and why they need your personal data are listed below:

Provider	Reason your data is shared
Hive Land & Planning Ltd	These are a Sub Processor of Tibbalds Campbell Reith, they have been sub-contracted to administer the public
	consultation.

Sometimes, we may be legally obliged to provide copies of personal information to other organisations. For example, to provide information to the police, or to a public inquiry. We might not be always able to tell you that we have shared your information in this way, however we will ensure this is only shared in accordance with the law.

Your personal data is shared with our third-party consultation provider (our Data Processor), Hive Land and Planning Ltd only for the purposes of this consultation. Your data will then be deleted by Hive Land and Planning Ltd once the redevelopment scheme has commenced on site, and under the terms of the contract.

Where is your personal data stored and processed?

All personal data is stored and processed by Hive Land and Planning Limited, on behalf of Homes England, within offices in the UK and using systems that utilise data centres in the UK.

If one of our service providers ever processes data outside the UK, we will ensure this is only where we can ensure that your personal data is adequately protected.

How long do we keep your personal data?

We will store your data up to the point the redevelopment has commenced on site, from the date that you initially registered your interest. This is to allow for planning submission, planning approval and commencement of works on site.

Your rights

Under data protection legislation, in certain circumstances you have the following rights over the processing of your personal data as described in this notice:

- Right of access to personal data.
- Right to correction or rectification.
- Right to request deletion.
- Right to data portability.

Homes England must respond to a request to exercise these rights within one month. If you would like to submit a request, please contact the data protection officer.
