#### **SWAINSON HOUSE FARM APPEAL**

An appeal has been lodged against the refusal of 95 homes at Swainson House Farm, Goosnargh Lane. **06/2025/0182**. The appellant accepts that the application is contrary to the Core Strategy and Local Plan, however the appeal **challenges the robustness of the City Council's 5 year housing supply** and argues that as the site relates well to existing housing in Goosnargh, **the role, function and purpose of the wider countryside would not be undermined.** 

The Parish Council remains opposed to housing development in the open countryside - particularly in an area which does not have the supporting infrastructure - and will remain **opposed to the application** at the appeal.

#### LONGRIDGE SPORTS VILLAGE

The Parish Council was made aware of a <u>consultation to create a sports village</u> on the Preston / Longridge boundary which includes 250 affordable homes to be provided by Community Gateway.

The site - **north of Inglewhite Road** - will have vehicular access from Chipping Lane and pedestrian access from Old Clay Lane.

The sports plans include

- a full-sized football pitch and two smaller 7-a-side pitches
- padel courts and indoor cricket nets
- a new 5k Park Run route

Once a planning application is submitted, the details and the Parish Council's comments will be added to our website.

#### WHITTINGHAM HOSPITAL SITE

Development of the former Whittingham Hospital site is complex and has taken several years to come forward. <u>A summary</u> is detailed on our website. Barratts have recently been granted permission to build the final **477 homes** and **develop the open space areas**.

The Parish Council has pledged to work closely with Barratts to ensure the history and importance of the site is reflected in the new development and open space areas.

#### WHITTINGHAM PRIMARY SCHOOL

The decision to build the new primary school has been delayed due to concerns regarding **access and parking arrangements**. The Parish Council is discussing the concerns with LCC in the hope that a suitable solution can be found.

Meanwhile, as the school is likely to open as an Academy, LCC are holding discussions to appoint a sponsor. To ensure local views are represented, a Parish Councillor will join the selection panel.

#### **PUBLIC OPEN SPACE**

The Parish Council maintains the play area and open space at **Cumeragh Village**. Repairs have recently been carried out to the play equipment and following positive feedback from residents, we can confirm that **Millars** will continue to maintain the grass in 2026.

**Goosnargh Village Green** is maintained by Preston City Council and having pledged to financially support a **Ninja style gym area** and **new equipment in the play area**, we continue to work with the City Council to ensure both projects are delivered before Easter.

Residents are also reminded that the Parish Council has produced leaflets detailing **2 country walks** around the parish. These can be **downloaded from our website** and we hope to inspect and add further walks during 2026.

#### REMEMBRANCE DAY

Thank you to everyone who supported the Parish Council's decision to add poppies to the lampposts on Church Lane to remember those who have died in wars and other conflicts. Plans are in place to expand the areas covered next year. A silhouette of a fallen soldier was also erected at the war tribute on **Beacon Drive**. Residents are reminded that the Parish Council wishes to enhance this area and would welcome ideas from residents. **Please contact the Clerk or a Councillor with your ideas**.

#### STJOHN'S CHURCH

The Parish Council values St John's Church as an important and historic building and Members of the Council agreed a <u>Concept Plan</u> to see if it could be brought back into life. The Council have



engaged **Buttress Architects** to assess if development of the Church is feasible. Residents were invited to a drop in event to suggest what the building could be used for and express views on this ambitious project. You can still take part in the survey by scanning the QR code.

More information will be added to the Parish Council website as the project progresses.
